3. PRODUCT DESCRIPTION:

Safe n Easy Ultimate Stone & Masonry Cleaner is a biodegradable product. It will safely remove a variety of contaminants from natural and manmade stone surfaces. Ultimate does not contain any bleach, abrasive, caustic, muriatic or hydrofluoric acids or petroleum distillates. It is formulated as a ready to use gel product and is generally used accordingly.

5. PREPARATION:

Ultimate Cleaner can be used to clean and restore stone, brick, masonry, unglazed ceramic, travertine, marble (unpolished and unglazed), granite, limestone, stucco, terrazzo, terra cotta and other similar type surfaces. It will remove stains, rust, chalking,

efflorescence, atmospheric stains and dirt without etching, pitting or damaging the surface or grout.

TEST AREA:

It is often impossible to know all of the conditions of the surface before cleaning. Before a project is started it is important that a small test area be done typical of the surface to be cleaned. Although Ultimate Cleaner is formulated to clean without etching glass, the user shall determine the suitability for the product for its intended use(s) and user assumes all risk and liability whatsoever in connection therewith. Keep away from plants and vegetation.

APPLICATION:

Use Ultimate Cleaner at full strength do not dilute. Apply solution from the bottom up. Let solution stand for approximately 20-30 minutes depending on surface and contaminates, agitate and rinse thoroughly.

HEALTH AND SAFETY: Corrosive liquid. Eye, skin and mucous membrane irritant. Contains fluorogens, which may be fatal if swallowed. Wear eye protection, rubber or latex gloves and chemical resistant footwear. **KEEP OUT OF THE REACH OF CHILDREN.** In case of contact with eyes, flush thoroughly with water for 15 minutes.
